**สมาคมตลาดตราสารหนี้ไทยประกาศอันดับผู้ค้าตราสารหนี้(Dealers)  
 ผู้จัดการการจัดจำหน่าย (Underwriters) และนายทะเบียน (Registrars)  
 ประจำปี 2561**

สมาคมตลาดตราสารหนี้ไทยขอประกาศอันดับของผู้ค้าตราสารหนี้ (Dealers) อันดับของผู้จัดจำหน่ายตราสารหนี้ (Underwriters) และนายทะเบียนตราสารหนี้ (Registrars) ปี 2561 เพื่อส่งเสริมข้อมูลธุรกรรมการค้าตราสารหนี้ของสถาบันต่างๆ ทั้งในตลาดแรกและตลาดรองให้แพร่หลาย ซึ่งจะเป็นประโยชน์ต่อผู้มีส่วนร่วมในธุรกรรมตราสารหนี้ โดยที่การประกาศอันดับนี้ จะดำเนินการในทุกๆ สิ้นไตรมาส

**อันดับผู้ค้าตราสารหนี้**

ปริมาณการซื้อขายตราสารหนี้ของปี 2561 มีมูลค่ารวมทั้งสิ้น 19,314,404 ล้านบาท ซึ่งคิดเป็นปริมาณการซื้อขายเฉลี่ยวันละ 78,834 ล้านบาท ปรับตัวลดลง 12.75% เมื่อเทียบกับปีก่อนหน้า (90,355 ล้านบาท)

ThaiBMA ได้ทำการจัดอันดับผู้ค้าตราสารหนี้ (Dealer) ที่มีธุรกรรมสูงสุด 5 อันดับแรก พบว่าผู้ค้าตราสารหนี้ที่มีมูลค่าการซื้อขายประเภท Outright Trading ในตราสารหนี้ระยะยาวที่มีอายุคงเหลือมากกว่า 1 ปี ได้แก่ ธนาคารฮ่องกงและเซี่ยงไฮ้แบงกิงคอร์ปอเรชั่นมีมูลค่าการซื้อขายสูงที่สุด โดยมี Market Share เท่ากับ 9.21% รองมาคือ ธนาคารกรุงเทพ 9.15% ธนาคารกรุงไทย 7.80% ธนาคารกสิกรไทย 7.59% และธนาคารซีไอเอ็มบีไทย 7.32% (ตารางที่ 1)

สำหรับอันดับของผู้ค้าตราสารหนี้ เมื่อพิจารณาจากมูลค่าการซื้อขายประเภท Outright Trading เฉพาะตราสารหนี้ประเภท Corporate Bond (ไม่รวม B/E) ได้แก่ ธนาคารทีสโก้มีมูลค่าการซื้อขายสูงสุด โดยมี Market Share เท่ากับ 22.05% รองลงมาคือ ธนาคารกรุงเทพ 18.86% ธนาคารซีไอเอ็มบีไทย 13.28% ธนาคารกสิกรไทย 11.04% และบริษัทหลักทรัพย์เคจีไอ (ประเทศไทย) 7.28% (ตารางที่ 2)

สำหรับอันดับของผู้ค้าตราสารหนี้ เมื่อพิจารณาจากธุรกรรม Outright ประเภท Corporate Bond (ไม่รวม B/E) สำหรับบริษัทหลักทรัพย์เฉพาะ 5 อันดับแรก ได้แก่ บริษัทหลักทรัพย์ เคจีไอ (ประเทศไทย) มีมูลค่าการซื้อขายสูงสุด โดยมี Market Share เท่ากับ 53.25% รองมาคือบริษัทหลักทรัพย์ คันทรี กรุ๊ป 12.53% บริษัทหลักทรัพย์ ภัทร 6.20% บริษัทหลักทรัพย์ เอเชีย พลัส 5.48% และ บริษัทหลักทรัพย์ ดีบีเอส วิคเคอร์ส (ประเทศไทย) 3.83% (ตารางที่ 3)

สำหรับอันดับของผู้ค้าตราสารหนี้ เมื่อพิจารณาจากมูลค่าธุรกรรมซื้อคืนภาคเอกชน (Private Repo) ของตราสารหนี้ทุกประเภทรวมกันโดยให้ความสำคัญกับจำนวนวันที่ทำการกู้ยืม (Repo Term) ได้แก่ ธนาคารยูโอบี มีมูลค่าของธุรกรรมสูงสุด โดยมี Market Share เท่ากับ 10.47% รองมาคือ ธนาคารเพื่อการเกษตรและสหกรณ์การเกษตร 9.78% ธนาคารกรุงไทย 9.45% ธนาคารกสิกรไทย 9.22% และ ธนาคารไทยพาณิชย์ 8.21% (ตารางที่ 4)

2.1 อันดับผู้จัดการการจําหน่ายตราสารหนี้ ภาคเอกชนระยะยาว (Lead Underwriter) 5 อันดับสูงสุด ได้แก่ อันดับหนึ่ง ธนาคารกสิกรไทย มีสัดส่วนการจําหน่ายเท่ากับ 22.13% อันดับสอง ธนาคารกรุงเทพ มีสัดส่วนเท่ากับ 14.42% อันดับสามธนาคารไทยพาณิชย์ มีสัดส่วนเท่ากับ 13.77% อันดับสี่ธนาคารกรุงไทยมีสัดส่วนเท่ากับ 12.47% และอันดับห้าธนาคารกรุงศรีอยุธยา มีสัดส่วนเท่ากับ 10.20% (รายละเอียดตารางที่ 6)

2.2 อันดับนายทะเบียนตราสารหนี้ภาคเอกชนระยะยาว 5 อันดับสูงสุด ได้แก่ อันดับหนึ่งธนาคารกรุงศรีอยุธยา มีสัดส่วนเท่ากับ 53.50% อันดับสอง ธนาคารไทยพาณิชย์ มีสัดส่วนเท่ากับ 17.96% อันดับสาม บริษัท ศูนย์รับฝากหลักทรัพย์ (ประเทศไทย) จำกัด มีสัดส่วนเท่ากับ 7.55% อันดับสี่ ธนาคารซีไอเอ็มบีไทย มีสัดส่วนเท่ากับ 7.20% และอันดับห้าธนาคารกรุงเทพมีสัดส่วนเท่ากับ 6.65% (รายละเอียดตารางที่ 7)
